APPLICATION RATE

For optimal performance, use from 15 to 20 oz. of **FOURSOME Plus** Turf Pigment per acre of turf with 16 oz. suggested as the initial rate.

DIRECTIONS FOR USE

1. Fill sprayer tank one-half to two-thirds volume of water.
2. With agitation on and following standard order of addition, add **FOURSOME Plus** Turf Pigment after dry flowable/dispersible granules and before water-soluble pesticide formulations.
3. Allow **FOURSOME Plus** Turf Pigment to fully disperse and mix into the spray solution before adding additional products.
4. Make application of pesticide solution mix to target site at rate specified on pesticide manufacturer's label.
5. After application, clean sprayer tank as per pesticide manufacturer's label.
